**\*Kazakhstan, America, Brazil, Bangladesh, Albania, Bosnia and Herzegovina, Kosovo, South Africa \***

**Deadline and Time for Application: 25 April 2025 16:00**

**Mobility period\* (optional): 25-26 Fall\*\*, 25-26 Spring**

\* In the application form, since the options of the preference period question are not intervened, all "summer" and "1 academic year" options are available. However, only "Fall" or "Spring" should be selected.

\*\*Nominations of students who choose the fall semester depend on the nomination and application dates of the partner institution. Students who choose the fall semester will be nominated for the spring semester if the fall semester nomination of the partner institution they choose is closed.

**Application Conditions:**

1. **full-time student** enrolled in a higher study program at any of the formal study levels (undergraduate, graduate, doctorate) within the higher study institution .  
\*Students studying in a double major can apply for mobility from only one major in the same application period. It is not possible to change departments after the application phase.
2. Students registered in an undergraduate program at our university can only apply for long-term (2-12 months) physical or mixed Student Mobility starting from their 2nd semester (excluding preparatory class).  
(*Students registered in the Preparatory Class cannot apply within the scope of this rule. It is required to be registered in the academic department/program as of the application opening date.*)  
There are quotas for undergraduate, graduate and doctoral students within the scope of this call for applications .

3. General Grade Point Average ( **GPA** ); ( (YNO) Semester Grade Point Average is not taken into account, General Grade Point Average is taken )
  - a. Undergraduate students must have a cumulative academic grade point average of at least 2.20/4.00 ,
  - b. Graduate and doctoral students must have a cumulative academic grade point average of at least 2.50/4.00.
4. **Having a sufficient number of courses or ECTS credit load** that is not a course for study mobility .

Example: The application of a student who is in the 4th year and has 10 ECTS credits left to complete to graduate is not valid for study mobility.

who do not have a course load and are in the **thesis** phase, a study agreement can be arranged based on a non-course workload of 30 ECTS in one academic term.
5. If the candidate has benefited from higher study mobility activities in the 2014-2020 and/or 2021-2027 Erasmus+ periods within his/her current study level, the total duration, including the new activity, should not exceed 12 months.

Example: If a student has completed an Erasmus study and internship mobility for 7 months (with or without a grant), he/she cannot apply for a mobility that will last 6 months. He/she can apply for a mobility that will last a maximum of 5 months.

#### **In order for the applications of the candidates to be valid;**

- Completely upload all the “ **Mandatory application documents** ” listed below and
- By clicking on the “ **COMPLETE APPLICATION** ” button in the system until the last application date / time. The status must be “ **COMPLETED** ” .

#### **Application Documents**

During the application process, candidates must upload the following documents to the National Agency Portal entered through the e-government system;

- Transcript Document (mandatory)
- Foreign Language Certificate (Compulsory for those who did not take the exam)

Students who have not taken the exam to be held by our University Preparatory Department must upload (only) valid documents from the exams specified below. It is not possible to upload documents after the application date.
- Students who are included in the scope of additional score criteria and additional grant support specified below must upload appropriate documents during the application phase; (mandatory for students who will be evaluated within this scope)

- To the children of martyrs and veterans
- For disabled students

Students who have been given protection, care or sheltering decisions within the scope of the Social Services Law No. 2828 and the Child Protection Law No. 5395.

- Those who or their first degree relatives received disaster victim aid from AFAD.
- Those subject to Law No. 2828 (Those who have a protection, care or shelter decision regarding them by the Ministry of Family and Social Services in accordance with Law No. 2828)
- Those who do not have any other parental income but receive an orphan's pension
- Those who are granted a monthly allowance to themselves or their family (it is sufficient for the student, their parents or guardian to submit a document proving that they received financial support from municipalities, public institutions and organizations (such as Ministries, Social Assistance and Solidarity Foundations, General Directorate of Foundations, Red Crescent, AFAD) at the time of applying for Erasmus.)
- Students whose one of their parents or guardians receives a disability or needy pension within the scope of the Law No. 2022 dated 01.07.1976 on Granting Monthly Allowances to Destitute, Weak and Helpless Turkish Citizens and Disabled and Needy Turkish Citizens who are 65 Years Old and Over.

### **Yeditepe University Foreign Language Exams:**

Candidates whose applications are valid will be informed separately about the date, time and place of **the Erasmus English Foreign Language Exam** to be held within the scope of this call for applications .

Students who have taken any Erasmus Foreign Language Proficiency Exam or Global Exchange Foreign Language Proficiency Exam in the 2024-2025 academic year will not be admitted.

### **Yeditepe University Erasmus Foreign Language Exams**

- Minimum successful foreign language score: 60 / 100
- Valid for two years.

### **Other documents accepted for English Proficiency:**

- Minimum successful English YDS / (e)YDS / YÖKDİL grade: 66 / 100
- Minimum successful English TOEFL IBT score: 79
  - TOEFL **IBT Home Edition** is **not** valid
- Minimum successful English TOEFL PBT score: 550

- TOEFL IBT and PBT exams are only accepted from Yeditepe University, Istanbul Technical University and Middle East Technical University exam centers.

### Evaluation;

**The Erasmus score** of students who meet the minimum requirements and pass the language exam is calculated by adding half of the GPA in the 100-point system and half of the language score.

**All criteria are as follows:**

Academic achievement level	50% (out of 100)
Language level	50% (out of 100)
To the children of martyrs and veterans	+15 points
For students with disabilities (provided that the disability is documented)	+10 points
Students who have been given protection, care or sheltering	+10 points

Those who or their first degree relatives received disaster victim aid from AFAD	+10 points
Previously benefited (with or without grant)	-10 points
Not participating in mobility without giving notice of waiver in time, even though selected for mobility	- 10 points
Participating in mobility in the country of citizenship	-10 points
Applying for two types of mobility at the same time (reduction is applied to the mobility type preferred by the student)	-10 points
For students selected for mobility: Failure to attend meetings/trainings organized by the higher education institution regarding mobility without an excuse (applies if the student re-applies to Erasmus)	-5 points
Declaring that you will take the language exam but not taking it without an excuse (applies if the student re-applies to Erasmus)	-5 points

Students whose Erasmus scores are created are ranked from the highest to the lowest points on a department/program basis; they are placed according to the partner university preferences stated in the application and the quotas of the partner universities.

Students who are eligible to receive a grant will be allocated a grant for a maximum of one term. Students' term extension requests are evaluated according to the additional grant and/or the remaining grant amounts of students who have withdrawn. If there is no grant for the student's term extension within the scope of this project, the student cannot perform the term extension process.

The grant payments are made in two instalments. The first payment is 80% of the total Erasmus+ grant. The payment of the second instalment depends on the students completing all the required procedures and on their academic standing (successfully completing/passing at least half of the course credits).

### **Additional Grant Support:**

Additional Grant Support may be provided to disadvantaged participants in addition to the grant they are entitled to. In order for the grant to be provided, a disadvantaged participant is defined as an individual with limited economic and social opportunities who fits the following subcategories;

1. Those subject to Law No. 2828 (Those who have a protection, care or shelter decision regarding them by the Ministry of Family and Social Services in accordance with Law No. 2828)
2. Students who have been given protection, care or sheltering decisions within the scope of the Child Protection Law No. 5395
3. Those who do not have any other parental income but receive an orphan's pension
4. Children of martyrs/veterans
5. Those who are granted a monthly allowance to themselves or their family (it is sufficient for the student, their parents or guardian to submit a document proving that they received financial support from municipalities, public institutions and organizations (such as Ministries, Social Assistance and Solidarity Foundations, General Directorate of Foundations, Red Crescent, AFAD) at the time of applying for Erasmus.)
6. Disabled People
7. Students who receive a disability or needy pension within the scope of Law No. 2022 dated 01.07.1976 on Granting Monthly Allowances to Destitute, Weak and Helpless Turkish Citizens and Disabled and Needy Turkish Citizens who are over 65 years of age, one of whose parents or guardians is a disabled or needy citizen.

**Credit and Hostels Institution scholarships and similar scholarships, other grants, aids and scholarships in the nature of success scholarships, and one-time aids are not accepted within the scope of the financial aid in question.**

Students who meet the above scope may be provided with Additional Grant Support in the following amounts, depending on the type of mobility, upon request and provided that they document their situation:

Type of mobility	Additional Grant Support Amount
Student mobility between 2-12 months	€250 per month
Short-term student mobility between 5-14 days*	€100 in addition to the daily grant total
Short-term student mobility between 15-30 days*	€150 in addition to the daily grant total
