# **Call for Applications**

What are Blended Intensive Programs? : It is an educational program (curriculum) and activity with physical and virtual components for students and academic and administrative staff of at least 3 higher education institutions in the program countries.

Coordinating Institution: Portugal, University of Coimbra

Partner Institutions: University of Siena, VU University Amsterdam

### **Duration / Place:**

**Physical Component**: 26-30 May 2025 / University of Coimbra, Coimbra, Portugal Training and group studies will be organized for one week at the University of Coimbra in Portugal.

**Virtual Component**: 31 January 2025, 2 May 2025, 17 June 2025 / Yeditepe University Remote Working Online seminars and projects will be carried out with all partners.

**Student Quota:** 3 Students

### **Application Conditions:**

- 1. Be registered as a full-time student in one of the departments/programs specified below;
  - 1. Institute of Health Sciences: Molecular Medicine, Pharmacy, Dentistry and Neuroscience Programs
  - 2. Institute of Science: Biotechnology Program
  - 3. Faculty of Medicine
- 2. Success (GPA): 3.00 / 4.00

#### Additional Evaluation Criteria

- Foreign Language Proficiency: Since the language of instruction in the programs in question is
  English, there is no document requirement; however, the scores of students with YDS, YÖKDİL,
  TOEFL documents will be converted to the 100-point system and 10% will be added to the 100point system equivalent of the students' GPA in the 4-point system. (TOEFL IBT Home Edition is
  not valid. It is only accepted from Yeditepe University, Istanbul Technical University and Middle
  East Technical University exam centers.)
- Inclusion:
  - a. First time participants those who have not participated in education and internship mobility before: +5
  - b. For disabled students: +5

Additional evaluation criteria points will be added to the to the equivalent of GPA in the 100 system . Students with an Erasmus score are ranked from the highest score to the lowest score on a

department/program basis. The first 3 students are eligible to go. The remaining 3 students are determined as reserve students.

**Grant Support:** The total Erasmus grant support to be allocated to our students for their physical mobility is <u>553 € (7\*79)</u> euros.

#### **Additional Grant Support:**

Disadvantaged participants may be provided with Additional Grant Support in addition to the grant they are entitled to. In order for the grant to be granted, a disadvantaged participant is defined as an individual with limited economic and social opportunities who fits into the following subcategories.

- 1) Those subject to Law No. 2828 (Those who have a protection, care or shelter decision regarding them by the Ministry of Family and Social Services in accordance with Law No. 2828)
- 2) Students who have been given protection, care or sheltering decisions within the scope of the Child Protection Law No. 5395
- 3) Those who are granted orphan/death pension
- 4) Children of martyrs/veterans and veterans themselves
- 5) Those who are granted a monthly allowance to themselves or their family (it is sufficient for the student, their parents or guardian to submit a document proving that they received financial support from municipalities, public institutions and organizations (such as Ministries, Social Assistance and Solidarity Foundations, General Directorate of Foundations, Red Crescent, AFAD) at the time of applying for Erasmus.)
- 6) Disabled People
- 7) Students who receive a disability or needy pension within the scope of Law No. 2022 dated 01.07.1976 on Granting Monthly Allowances to Destitute, Weak and Helpless Turkish Citizens and Disabled and Needy Turkish Citizens who are over 65 years of age, one of whose parents or guardians is a disabled or needy citizen.
- 8) Those who or their first degree relatives receive disaster victim aid from AFAD (Applied only once. If selected, no additional grant support will be provided in this category for the student's subsequent mobility.)

Credit and Hostels Institution scholarships and similar scholarships, other grants, aids and scholarships in the nature of success scholarships, and one-time aids are not accepted within the scope of the financial aid in question.

Students who meet the above scope may be provided with additional Grant Support in the following amounts depending on the type of mobility, upon request and provided that they document their situation: For short-term student mobility between 5-14 days\*, a total of €100 for 5 days in addition to the daily grant total.
